## ***Clean Fuels Project 2004***

The Low Sulfur Gasoline Clean Fuels project is paving the way for healthier air in our region, and changing the way we operate and do business. The Clean Fuels Project, regulated by the Environmental Protection Agency (EPA) under the Tier II phase of the Clean Air Act, will help all Americans breathe easier by significantly reducing the sulfur content of all gasoline pollution emitted from motor vehicles. Because sulfur in gasoline degrades a vehicle's emission control system, all gasoline producers are being required by the EPA to lower the sulfur levels of the gasoline they produce. In our case, gasoline sulfur will be reduced from the current average of 380 ppm (parts per million) to less than 80 ppm sulfur in 2004 and to an average of 30 ppm sulfur by 2006.

Needless to say, the Phillips team has been hard at work developing and implementing a solution to lower the sulfur content in our gasoline streams. We began tackling this project in early 2001, finalized a solution in April 2002, and have now begun to implement these changes to our gasoline streams. We expect the project to be completed and on stream by November 2003.

The project will utilize the site of the idle DAU in the Lubes area to install a new Cat Naphtha Splitter (CNS). Fractionation of our full range FCC naphtha will take place both in this new splitter column and in the existing C-6 column. The new Splitter will separate 44 MBD of FCC gasoline into light, intermediate, and heavy fractions. Feed to the column will come from the FCC Gas Plant Debutanizer and Rich Oil Still columns. The new splitter will utilize some existing equipment and infrastructure and install a new column and reboiler as well as new pumps.

The process units for this project, Cat Naphtha Splitter (CNS) and Heavy Cat Naphtha Hydro Treater (HCNHT), will be located in two currently idle units, CDU and DAO, which are near the Lubes area of the plant. Some existing equipment is being used in this sulfur-reduction project, but much new equipment had to be purchased as well, with additional minor work at C-6 and the GHT. The cost of this project is estimated at nearly \$100 million.

The existing Rich Oil Still and C-6 columns will provide 19 MBD fractionation capacity in parallel with the CNS. The C-6 overhead system will be debottlenecked and reliability improvements made.

When finished, Phillips will produce gasoline that contains less than 80 ppm sulfur content by 2004. Though we chose the most cost-effective

## **Refinery Management Team sets refinery Mission, Vision and Values**

The Refinery Management Team has been working for some time to get their view of the Wood River Refinery Mission, Vision and Values down on paper. In addition to their own discussions, the RMT sent early drafts of the MVV to all employees for feedback and sponsored several focus groups to gain more input. At a recent extended workshop, the RMT concluded their work and prepared the statement introduced here.

As this work has progressed, members of the RMT and employees throughout the plant have asked, "Why create a Mission, Vision and Values for Wood River? Doesn't Phillips have a Mission Statement already?" The answer, of course, is that Phillips does have a Mission Statement [see box below] and we at Wood River are an important part of that mission. Nevertheless, the RMT believes that Wood River needs its own statement, one that can stand for the refinery throughout the uncertainties that have been a part of our history for the last 10 years.

A statement of Mission, Vision and Values starts out as words on paper. For the statement to have meaning, it must become a part of how the work of the refinery is accomplished, it must be the guidepost that shows the path for all our decision making. To ensure that all employees have a chance to discuss the statement and think through how it can affect their approach to their jobs, the RMT will be helping to lead a series of discussions on the Mission Vision Values.

Initially, the RMT will engage refinery supervisors in a discussion of the statement and its purpose. The RMT has plans to meet with senior supervisors to review the priorities for Wood River, as seen in light of the refinery's mission and the vision for our future. These supervisors will be asked to provide feedback to the RMT on the positive changes they have observed over the last



## Refinery Manager's Corner...

Through the middle of June, Wood River is doing well on controllable performance, although the market environment is much less favorable than last year. With only four recordable injuries and no lost-time injuries, Phillips employees are on track to set a new safety record in 2002. Contractor safety perform-

ance is improving, but still unacceptable with an OSHA rate above 3.0. SH&E initiatives have been ranked to ensure that the highest priority items are addressed first.

Environmental performance is also on track to set a record for the second year in a row. There has not been a dock spill in over one year, and the new cyclones at CCU-2 have significantly reduced air violations.

Reliability initiatives are improving unit on-stream factors and reducing maintenance costs. Multi-year programs to improve infrastructure are making the refinery safer and more reliable. A greater focus on predictive and preventive maintenance will help reduce repair costs. The turnaround process is being revamped to help reduce maintenance costs. Spending in all areas is being scrutinized to ensure that the expense budget is met for the year.

Energy initiatives are receiving greater attention thanks to the newly formed energy team. Steam leaks and vents across the refinery have been reduced, heater and boiler efficiency is improving, and higher priority is being placed on returning energy recovery equipment to service. The Reverse Osmosis Unit has started up, which will improve energy efficiency and reduce waste disposal costs.

Gross margin productivity continues to improve thanks to good operations across the refinery and capital upgrades at CCU-2, the SMR, and Vacuum Flasher No. 1. Seasonal alkylate storage was used to produce record volumes of reformulated gasoline in April and May. A CCU-1 yield improvement project is under development for CCU-1. Phase I of the Wood River low-sulfur gasoline project is under way.

People continue to be a top priority with efforts to rebuild the business unit teams and engage everyone in improving the business. The management team commitment to a common mission, vision, and values was communicated to the work force. With your continued support, Wood River will achieve the vision of becoming a leader in our industry as measured by safety, operating excellence, and profitability. Thanks for your continued dedication and commitment – together we will win the game!

solution for this project, ultimately these gas streams will have a higher cost of production due to utility, operations and maintenance of the equipment. However, when we are required to further reduce sulfur content to 30 ppm in 2006, there will be no need of an additional investment of new equipment or reworked equipment in these units. Future work, if required for desulfurization, will occur in other process units.

The idled CDU in the Lubes area will be revamped to process 28 MBD of heavy cat naphtha. The unit will be operated similar to a conventional hydrotreater with an additional bed of special catalyst. The product out of this unit will have a sulfur level less than 5 ppm S. A significant portion of the idled equipment, including the heater, reactors, and compressor will be reused. New equipment includes a stabilizer column and additional heat exchange.

The existing GHT unit will be switched from processing cat naphtha to treat light straight run gasoline. Additionally, significant work is included in the project for infrastructure modifications.

The Phillips project team during the development of a sulfur-reduction solution was led by Dave Hutton, and consisted of Greg Witte, Becky Talley, Jack Brisky, Bill Cloyd, and Dave Carpenter as key players. The project execution team's current members are leader Stuart Mills, with Dave Eglinton, Greg Witte, Jack Brisky, Dave Carpenter, Ed Cope, Clint Rybak, Kevin Gimmy, Mike Johnson, Pam Rush, and help from numerous support personnel. Mills and Eglinton recently have transferred to Wood River from the Phillips' Sweeny and Borger refineries and both have valuable experience within Phillips in executing projects. Additional employees, under the direction of Val Huntsman, will be required for daily operation of the equipment.

## Dock operations flowing great

All the employees working in the area of the dock have a lot to be proud of. On June 10<sup>th</sup> the area celebrated one year without a spill to the river. A spill is considered to be as little as a drop. Our last spill was approximately one pint of diesel from a newly installed Cat Feed Line. Past years have plagued us with about 6 incidents per year.

This outstanding accomplishment can be credited to many things. There has been increased operator surveillance and higher awareness of all employees in this area over the past few years. At the same time, our operators and supervisors have worked harder to build relationships between dock personnel and the towing companies, independent tankering companies, and inspection companies to prevent incidents and spills at our facility.

Improvement projects also continue in this area. Recently there have been great efforts made in dock cleanup that have included fresh paint, redefining ditches, and removal of fence lines and cluttered areas. Also, spill containment projects are underway to include: more efficient Benzene loading arm and vapor hose, surge suppressors on the camera system, upgrade gauging system on slop tanks, demolition of the old truck rack system and several underground lines, and the elimination of several lines and valves that were no longer in service. The team also worked hard to eliminate several potential leak points that were found during the annual line testing activities.

The onset of spring flooding added to the challenges that the employees face everyday in keeping the waters free of product. Late May rains caused a sudden burst of flooding and brought the Mississippi River levels up to levels not seen for a few years. Although those operating in this area were presented with challenges, all rose to the occasion. This benchmark was reached despite the very high waters and all the debris that comes with the flooding.

The results are plentiful in this area because of the commitment of those who work there. In addition to the record, the operators and those who support this area continue to show their commitment and ownership to their very specialized area.

Congratulations to the all the operators and staff that work in this area for your hard work throughout the year and for accomplishment of one year without a spill.


